ORDINANCE NO. 1910

**AN ORDINANCE ESTABLISHING CHAPTER 120,
OF THE SWANSEA MUNICIPAL CODE REGARDING
REGULATION OF TOBACCO PRODUCTS**

WHEREAS, the Village of Swansea Board of Trustees is committed to promoting the health, safety, and welfare of its residents; and

WHEREAS, the use of tobacco products, particularly among minors, poses significant health risks, including additions, respiratory issues, and other serious health conditions; and

WHEREAS, the Village of Swansea seeks to prevent the sale and distribution of tobacco products to individuals under the age of 21, consistent with state law and regulations; and

WHEREAS, it is in the public interest to regulate the sale, possession, and use of tobacco products within the Village of Swansea to protect public health.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF SWANSEA, ILLINOIS:

SECTION 1: The Board of Trustees of the Village of Swansea hereby adopts the recitals in the preamble of this Ordinance as its findings of facts.

SECTION 2: Chapter 120 is hereby amended a copy of which is attached hereto as Exhibit A and incorporated herein by reference.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are repealed to the extent of such conflict.

SECTION 4: This ordinance shall be in full force and effect, following its passage, approval and publication in pamphlet form as provided by law.




