ORDINANCE NO. 1989

AN ORDINANCE AMMENDING THE CODE OF ORDINANCES CHAPTER 78:  
SCHEDULE I. NO PARKING ZONES

*WHEREAS*, the Village of Swansea has a responsibility to maintain the safety, accessibility, and orderly use of public streets; and

*WHEREAS*, unregulated parking along Ambrose Terrace has resulted in traffic congestion, reduced visibility, and limited emergency access; and

*WHEREAS*, it has been determined that the installation of no parking signs is necessary to ensure public safety, visibility, emergency access, and safe traffic flow;

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF SWANSEA, ILLINOIS:**

***SECTION 1: PURPOSE***

For the purpose of this Ordinance, no parking signs shall be installed in the location described as:

In the boulevard or strip of grass between the sidewalk and the street on the western side of Ambrose Terrace, east of 1759 Ambrose Terrace spanning approximately 126 feet around the bend of the road, terminating south of the driveway at 1743 Ambrose Terrace.

***SECTION 2: PENALTIES***

It shall be unlawful for any individual to park in any area specifically designated as a no parking area and fines may be issued as outlined in §72.55 of Village Code.

***SECTION 3: EFFECTIVE DATE***

This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by law.


