**WHEREAS**, it is the desire of the corporate authorities of the Village of Swansea to dispose of said surplus personal property pursuant to the above referenced statute,

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF SWANSEA, ILLINOIS:**

**SECTION 1:** The Board of Trustees of the Village of Swansea hereby adopts the recitals in the preamble of this Ordinance as its findings of fact.

**SECTION 2:** The Board of Trustees directs that the personal property referred to herein be sold and authorizes the Village Administrator to carry out that directive.

**SECTION 3:** This ordinance shall be in full force and effect after passage, approval and publication in pamphlet form as provided by law.


