ORDINANCE NO. 8004

AN ORDINANCE AMENDING SECTION 114.03: VIDEO GAMING, WITHIN  
CHAPTER 114

*WHEREAS*, The Village finds that the placement and operation of video gaming terminals within the community must be regulated in a manner that protects the public welfare, maintains the character of surrounding areas, and supports responsible economic development.; and

*WHEREAS*, to that end, the Authority designated under this code deem it necessary to retain discretion over the number and type of video gaming licenses issued, ensuring that each approval aligns with the Village's zoning, land use, and public policy objectives.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF SWANSEA, ILLINOIS:**

***SECTION 1: AMENDING SECTION 114.03 SUBSECTIONS (C)(1), (2), (3)(b), (4), (5)(b), & (6)(B) TO READ AS SUCH:***

**(C)(1)** - Class A permits shall authorize the placement of video gaming terminals in establishments where estimated net revenue of at least sixty percent (60%) derives from a combination of the sale of food prepared on site and the sale of alcoholic liquor consumed on premises. There shall be no more than 4 Class A licenses issued.

**(C)(2)** - Class B permits shall authorize the placement of video gaming terminals in establishments with a convenience store that sells at retail a minimum of 10,000 gallons of fuel per month or where at least seventy-five percent (75%) of net revenue derives from retail sales. There shall be no more than 5 Class B licenses issued.

**(3)(b)** – There shall be no more than 5 Class C licenses issued. No Class C establishment shall be located within 1,000 feet of another Class C establishment, or within 1,000 feet of any car title loan or payday loan establishment. Determination of distance between said establishments shall be from the nearest entrance of each establishment.

**(C)(4)** - Class D permits shall authorize the placement of video gaming terminals in fraternal establishments having a fraternal purpose where membership is based upon a common tie or the pursuit of a common object. There shall be no more than 2 Class D licenses issued.

**(C)(5)(b)** – There shall be no more than 1 Class E licenses issued.

**(C)(6)(b)** – There shall be no more than 1 Class F licenses issued.

**SECTION 2: SEVERABILITY**

If any provision of this Ordinance or its application to any person or circumstance is held invalid or unconstitutional by a court of competent jurisdiction, such invalidity shall not affect the remaining provisions or applications of the Ordinance that can be given effect without the invalid provision or application.

**SECTION 3: EFFECTIVE DATE**

This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by law.
