ORDINANCE NO. 2005

AN ORDINANCE OF THE VILLAGE OF SWANSEA, ST. CLAIR COUNTY, ILLINOIS, ESTABLISHING
TAX LEVIES FOR ALL CORPORATE PURPOSES
TO BE LEVIED AGAINST ALL PROPERTY SUBJECT TO TAXATION WITHIN
THE VILLAGE OF SWANSEA, ILLINOIS FOR THE PURPOSE OF PROVIDING FUNDS FOR THE
FISCAL YEAR COMMENCING MAY 1, 2026 AND ENDING APRIL 30, 2027

***NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF
TRUSTEES OF THE VILLAGE OF SWANSEA, ILLINOIS:***

SECTION 1: GENERAL CORPORATE PURPOSES

That a tax for the following sum of money, or as much therefore as may be authorized by law to defray all General Corporate expenses and liabilities of the Village of Swansea, shall be, and hereby is, levied in accordance with the Illinois Compiled Statutes, Chap. 65, section 5/8-3-1, against all taxable property in the Village of Swansea for the fiscal year commencing May 1, 2026 and ending April 30, 2027.

General Corporate Purposes: \$221,340.00

SECTION 2: ILLINOIS MUNICIPAL RETIREMENT FUND

That a tax for the following sum of money, or as much therefore as may be authorized by law to sufficiently meet the requirements of the pension fund, exclusive of all other rates extended, shall be, and hereby is, levied in accordance with the Illinois Compiled Statutes, Chap. 40, section 5/7-171, against all taxable property in the Village of Swansea for the fiscal year commencing May 1, 2026 and ending April 30, 2027.

Illinois Municipal Retirement Fund: \$169,320.00

SECTION 3: MUNICIPAL FIRE PROTECTION

That a tax for the following sum of money, or as much therefore as may be authorized by law to defray all expenses and liabilities of the Village of Swansea for providing Municipal Fire Protection, shall be, and hereby is levied in accordance with the Illinois Compiled Statutes, Chap. 65, section 11-7-1, against all taxable property in the Village of Swansea for the fiscal year commencing May 1, 2026 and ending April 30, 2027.

Municipal Fire Protection Fund: \$229,500.00

SECTION 4: MUNICIPAL FIRE PENSION FUND

That a tax for the following sum of money, or as much therefore as may be authorized by law to defray all expenses and liabilities of the Village of Swansea for providing Municipal Fire Pension Fund, shall be, and hereby is, levied in accordance with the Illinois Compiled Statutes, Chap. 40, section 5/4-118, against all taxable property in the Village of Swansea for the fiscal year commencing May 1, 2026 and ending April 30, 2027.

Municipal Fire Pension Fund: \$163,200.00

SECTION 5: MUNICIPAL POLICE PROTECTION

That a tax for the following sum of money, or as much therefore as may be authorized by law to defray all expenses and liabilities of the Village of Swansea for providing Municipal Police Protection, shall be, and hereby is, levied in accordance with the Illinois Compiled Statutes, Chap. 65, section 5/11-1-3, against all taxable property in the Village of Swansea for the fiscal year commencing May 1, 2026 and ending April 30, 2027.

Municipal Police Protection: \$219,734.00

SECTION 6: MUNICIPAL POLICE PENSION FUND

That a tax for the following sum of money, or as much therefore as may be authorized by law to defray all expenses and liabilities of the Village of Swansea for providing Municipal Police Pension Fund, shall be, and hereby is, levied in accordance with the Illinois Compiled Statutes, Chap. 40, section 5/3-125, against all taxable property in the Village of Swansea for the fiscal year commencing May 1, 2026 and ending April 30, 2027.

Municipal Police Pension Fund: \$1,636,888.00

SECTION 7: MUNICIPAL AUDITING

That a tax for the following sum of money, or as much therefore as may be authorized by law to defray all expenses and liabilities of the Village of Swansea for the Annual Municipal Audit, shall be, and hereby is, levied in accordance with the Illinois Compiled Statutes, Chap. 65, section 5/8-8-8, against all taxable property in the Village of Swansea for the fiscal year commencing May 1, 2026 and ending April 30, 2027.

Municipal Auditing Tax: \$16,528.00

SECTION 8: TORT JUDGMENTS, GENERAL AND LIABILITY INSURANCE

That a tax for the following sum of money, or as much therefore as may be authorized by law to defray all expenses and liabilities of the Village of Swansea for Tort Judgments and General and Liability Insurance, shall be, and hereby is, levied in accordance with the Illinois Compiled Statutes, Chap. 745, section 10/9-107, against all taxable property in the Village of Swansea for the fiscal year commencing May 1, 2026 and ending April 30, 2027.

Tort Judgments, General and Liability Insurance: \$59,713.00

SECTION 9: PUBLIC PARKS

That a tax for the following sum of money, or as much therefore as may be authorized by law to defray all expenses and liabilities of the Village of Swansea to purchase, establish, and maintain public parks for the use and benefit of the inhabitants of the municipality, shall be, and hereby is levied in accordance with the Illinois Compiled Statutes, Chap. 65, section 5/11-98-1, against all taxable property in the Village of Swansea for the fiscal year commencing May 1, 2026 and ending April 30, 2027.

Public Parks: \$66,300.00

SECTION 10: RECAPITULATION

That the following is a recapitulation of all property taxes to be levied by the Village of Swansea for the fiscal year commencing May 1, 2026 and ending April 30, 2027.

SECTION 11: VALIDITY

That if any part of this Ordinance shall be judged invalid, such judgment shall not affect, impair, or invalidate the remainder of this Ordinance, which shall remain in full force and effect.

SECTION 12: FILING

That the Clerk of the Village of Swansea shall prepare and file a duly certified copy of this Ordinance with the County Clerk of the County of St. Clair, immediately following its passage and approval.

SECTION 13: EFFECTIVE DATE

That this Ordinance shall be in full force and effect ten (10) days from its passage, approval, and publication in pamphlet form.



