WHEREAS, the disposal of municipal personal property is governed by 65 ILCS 5/11-76-4 of the Illinois Municipal Code; and

WHEREAS, the Board of Trustees of the Village of Swansea has determined that this personal property is no longer necessary or useful, and that it is no longer in the best interest of the Village to retain ownership of same; and

WHEREAS, the Board of Trustees of the Village of Swansea hereby declares said personal property to be surplus property; and

WHEREAS, it is the desire of the corporate authorities of the Village of Swansea to dispose of said surplus personal property pursuant to the above referenced statute,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF SWANSEA, ILLINOIS:

SECTION 1: The Board of Trustees of the Village of Swansea hereby adopts the recitals in the preamble of this Ordinance as its findings of fact.

SECTION 2: The Board of Trustees directs that the personal property referred to herein be sold and authorizes the Village Administrator to carry out that directive.

SECTION 3: This ordinance shall be in full force and effect after passage, approval and publication in pamphlet form as provided by law.
